What is the Project Based Section 8 housing program?

Project Based Section 8 housing is a government-funded program that provides rental housing to low-income households in privately owned and managed rental units. The subsidy stays with the building; when you move out, you no longer have the rental assistance. Most units rental cost will be 30% of your household adjusted gross income. There may be a variety of housing types available through this program including single-family homes, townhomes, or apartments.

If you completed a homeless assessment and are on the Coordinated Entry Supportive Housing list, this list is an additional resource for you. You may apply for these properties in addition to the supportive housing list:

Rural development and project based section 8 do not require applicants to be homeless. Coordinated Entry only assists households experiencing homelessness. If you are homeless, call your point of access to see if you are eligible for a homeless assessment AND get on any wait lists you qualify for from the above list. They are two different processes.
